

Alfred Deschberger

- dealing with objections
 - \circ After the previous decision from the meeting 10/2017, the competition would have to be interrupted
 - o The appeal ist o be treated as soon as possible
 - o If the four main judges are deducted, the competition must be suspended or the evaluator one will be the main judge for the processing time of the appeal
 - o interruption would mean delay
 - o If judge 1 becomes the main judge, quality may suffer
 - o proposal: a competistion management decides on objection
 - competition leader should have two deputies, all 3 handle the appeals (a total of three different nations)
 - Frank Hermes and Corrado Paoli should be the deputies

Austria

- Very important that the two deputies are members of the commission
- IYLC must agree

CM

- In Luxembourg, it was decided that the four main judges and the competition leader should respond to objections
- Proposal by Alfred Deschberger from a practical point of view, so that the competition is not interrupted
- Especially at joint events with the adults there would be time problems
- In Budapest, talked about deputies
- The competition would continue while the three would decide within 15 minutes

Luxembourg

- What happens when a nation of one of the members is affected?

CM

- By being three different nations, there is no problem because the majority decides
